He was born in Collevocchio in the province of Rieti in 1968 and moved to Rome with his family in 1971.

He graduated as a surveyor in Rome in 1987 and, after the training period, he became a Member of the Board of Surveyors of the Province of Rome, no. 7607, in 1993.

His training as a loss adjuster began at an early age and ran concurrent with his studies as a technical surveyor; he began working as an apprentice after school in February 1985, at Studio Tecnico dell'Arch. Gian Marco Giordano, "elementary classes" expert and trustee of leading insurance companies, then operating on the national territory.

During his five years at the studio (Feb. 1985 - October 1990), in addition to discovering the vast world of insurance and perceiving the great professional strategic opportunity of the Insurance Expert, he sensed the great evolution that the Italian insurance market would have for social and economic development, as "Globalisation and Information Technology" would lay the groundwork, that has today materialised, thus taking care of professional, training and entrepreneurial aspects. In the five years of his apprenticeship, in addition to settling Property policy claims, he began to take a particular interest in the vast world of Liability, initially linked to buildings only, then extended in subsequent years to different entrepreneurial, commercial, professional, productive, institutional and relationship circumstances.

In 1988 he acquired his first Insurance Customer, Norditalia Insurance (now incorporated in Carige Assicurazioni) and in 1989 the second Customer, Latina Renana, merged into The Provident Group, thus, he also became trustee of Provident Insurance.

In 1990, he completed his training and started out on his own career path by establishing a professional firm, highly computerised for the time, which formed the nucleus of subsequent technological developments.

In 1993 he acquired his third Customer in the Zurich Group and started to gain experience of international insurance products and handling companies and enterprises.

In 1994 he formed a relationship with The Mannheim Company, now incorporated in HDI Insurance.

In 1996 he created the first company called "Studio Tecnico Pulimanti sas", which marked the move from a professional structure to a business organisation able to offer a response in terms of numbers, quality and location, conducting surveys on behalf of its customers in the (Lazio) region and beyond.

In 1998 he registered as a member of the expert Association, ASSIT, after a brief period in another association, in order to actively follow the evolution of the market, upgrade his (and his co-workers) professional technical skills and continuously improve their own "risk" culture.

In 2000 he founded a second company, conceived and organised for the management of common claims, called GSM Italia srl, where, in addition to being one of the founding shareholders, he served as Chairman of the Board, Co-Director, Technical Director for complex Property and Liability claims, acquiring more customers, such as the General Group and extending his areas of activity to the world of Transport, the latter carried out on behalf of Allianz and Unipol Group; aviation for surface damage and gaining further experience in the industrial world of the product, the professions, the management of convention policies, both with regard to Property and Third Party Liability.

In 2001 he obtained certification as an ANIA expert for claims relating to seismic, catastrophic and natural events, by attending the training course organised by the Civil Protection Department and ANIA.

In 2009 he worked on behalf of Insurers and the Civil Protection Department in the aftermath of the earthquake that hit the Abruzzo region, settling claims for direct and indirect damage to commercial and manufacturing activities; on convention policies in favour of Federfarma, active in 42 of the affected municipalities, settlement of claims for stored goods and the inactivity of member pharmacies. On behalf of the Civil Protection Department, he assessed claims of contributions paid for non-structural damage until sums from public funds were allocated.

In 2009 he founded his third company called Integrated Services Insurance srl, designed and structured for emergency management of complex claims throughout Italy and management of common claims in Central Italy, working in Marche, Lazio, Abruzzo, Umbria and Tuscany through a centralised system, with an operations base in the Capital and some his own agents in the field operating by teleworking.

In June of 2010, he left GSM Italy srl to devote himself full time to the newly established ISI srl (as Sole Shareholder) structured and organised to operate in complex and recurring claims, for primary National and International Insurance Groups, celebrating thirty years of activity in February 2015.

In October 2010, he graduated as a Risk Manager, in "Environmental Risk Assessment and Management" from the Politecnico di Milano.

On his career path, he has gained experience of claims settlement in the following areas: energy risks, pollution, catastrophe risks, CAR fire, industrial risks, theft, Real Estate and Ten Year guarantee. For Product Liability, Company Third Party Liability, Workers' Liability and Professional Liability Claims.

He is used by Insurers and Companies for technical advice in both civil and criminal (Workers' Liability) legal proceedings, he has managed and still manages convention policies for: ATER, ENASARCO, BANCA D'ITALIA, INPS (Social Security), PENSION FUND, BANCA DI ROMA, ITALIAN NATIONAL RAILWAYS, ANAS, SOC. AUTOSTRADE PER L'ITALIA SPA, ACEA GROUP, TELECOM SPA, SALCEF, TOTO SPA ", as well as working on policies for ordinary and recurrent risks.

In September 2014 he enrolled in ANRA, where he is following training to improve his risk culture and to be in ever closer touch with the business world and its problems, constantly updating his insurance products on the international and domestic market.
